**REFUND:** All refund requests must be submitted in writing within 45 days of scheduled completion of trip. No refunds will be made due to delays or changes in airlines schedules, or any individual decision not to participate.

**DOCUMENTATION:** U.S. Citizens require proof of citizenship consisting of a valid passport. Losses or delays resulting from failure to present proper identification when required will not entitle you to any refunds.
